Dear Parent/Guardian of 7th grade student:

Seventh grade students **are required to** show proof of receiving several booster immunizations to start school in September according to the Minnesota State Law 121A. Proof of the following immunizations or a notarized form indicating you are conscientiously objecting to more immunizations must be provided to the health office no later than the first day of school on September 6, 2022.

- 2 Measles, Mumps and Rubella (MMR) (1st dose must be after age 1)
- 1 Tetanus Diphtheria Pertussis (Tdap) Booster given after age 11
- 3 Polio Immunizations
- 3 Hepatitis B Immunizations
- 2 Chicken Pox (Varicella) (given after 1 year of age and at least 28 days apart) or date of disease verified by MD
- 1 Meningococcal Immunization (given at age 11-12)

You are able to see the immunization dates we have on file at school through your Farmington Family Web access at www.farmington.k12.mn.us under Health. Unless your child has received the required booster shots, they will be listed as non-compliant after July 1, 2022 when the school calendar is changed to 2022-23 and your child is considered a 7th grade student.

If your student will not be getting required immunizations because they have had the chicken pox disease or if you are choosing the conscientious objection option this must be submitted on the Pupil Immunization Record. The link is listed below. **Please note conscientious objection intentions must be signed in front of a notary public to be valid. If your child had the chicken pox disease, it must be documented by your medical provider on the Pupil Immunization Record or on the clinic immunization print out.**

Sports Physical: Students participating in sports are required to have a sports qualifying physical every 3 years. Please refer to the district web site at www.farmington.k12.mn.us, Farmington High School, Athletics to access a copy of the preferred form. Well child reports do not meet the requirements for sports physical. Please submit a completed copy to the Athletics Office at Farmington High School prior to your child’s participation in the sport.
